

**ALLIANT CREDIT UNION BEYOND BOOST SWEEPSTAKES
OFFICIAL RULES**

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**
- 2. ELIGIBILITY:** The Alliant Credit Union Beyond Boost Sweepstakes (“**Sweepstakes**”) is open only to legal residents of the fifty (50) United States and the District of Columbia (the “**U.S.**”) who are eighteen (18) years of age or older (or the age of legal majority in their place of residence, whichever is older) as of September 21, 2026 (“**Entrant**”). Becoming an Alliant Credit Union member is not required to participate in this Sweepstakes. Void in all U.S. territories and possessions and where prohibited. Employees of Alliant Credit Union (“**Sponsor**” or “**Alliant Credit Union**”), Neighborhood Intelligence, Inc. (“**Beyond**” or “**Promotion Partner**”), and its respective parents, successors, affiliates, subsidiaries, trustees, and client financial institutions, prize suppliers, paid influencers, and advertising and promotion agencies, Don Jagoda Associates, Inc. (“**Administrator**”), and each of their respective agents, representatives, officers, directors, shareholders, and employees (collectively, the “**Releasees**”), and each of their immediate family members (spouse or partner, parents, children, siblings, and their respective spouses or partners, regardless of where they live) and individuals living in the same households of each of these individuals, whether related or not, are not eligible to enter or win the sweepstakes. The sweepstakes is subject to all applicable federal, state, and local laws. The Sweepstakes is governed by Illinois law and, to the extent applicable, federal law.
- 3. SWEEPSTAKES TIMING/DESCRIPTION:** The Sweepstakes begins at 12:00 AM Central Time (“**CT**”) on September 21, 2026, and ends at 11:59:59 PM CT on December 31, 2026 (the “**Sweepstakes Period**”). The Sweepstakes Period consists of four (4) entry periods (each, an “**Entry Period**”), as follows:

- 4. TO ENTER:** There are two (2) ways to enter:
 - **AUTOMATIC ENTRY:** An Entrant who becomes a new Alliant Credit Union member by opening an eligible High-Rate Savings (S01) account via the **Alliant Credit Union Journey Home Savings Promotion** promotional landing page URL [\[https://promo.alliantcreditunion.org/journeyhomesavings\]](https://promo.alliantcreditunion.org/journeyhomesavings) during the Sweepstakes Period or who is already an existing Alliant Credit Union member with an eligible Alliant Credit Union High-Rate Savings (S01) account prior to the start of the Sweepstakes Period and visits the promotional landing page URL [\[https://promo.alliantcreditunion.org/journeyhomesavings\]](https://promo.alliantcreditunion.org/journeyhomesavings) and opts in to the **Alliant Credit Union Journey Home Savings Promotion** will automatically receive one (1) entry into the Sweepstakes for each Entry Period as defined above in which they make at least one (1) mobile check or cash deposit of \$300 or more (a “**Qualifying Deposit**”) into their eligible Alliant Credit Union High-Rate Savings (S01) account (“**Automatic Entry**”), regardless of the number of Qualifying Deposits received in that Entry Period, up to a total of four (4) Automatic Entries overall for the Sweepstakes Period. Certain deposits do not qualify for Automatic Entry, including dividend credits, promotional credits, direct or non-direct deposit ACH transfers, inter- or intra-bank peer-to-peer transfers, or transfers made to debit cards from digital wallets or P2P services (PayPal, Venmo, Cash App, Zelle, Google Pay, Facebook Pay, or other similar services). A Qualifying Deposit is dependent upon the date on which the deposit has been posted to the eligible Alliant Credit Union High-Rate Savings (S01) account. In order to qualify

for Automatic Entry, the Qualifying Deposit must be posted to the eligible Alliant Credit Union High-Rate Savings (S01) account by the end date of the respective Entry Period as defined in the chart above. Automatic Entries will not carry forward to subsequent Entry Periods. Account must be "In good standing" meaning the account (as of the end date of the respective Entry Period as defined in the chart above) is not overdrawn, dormant or delinquent and has not caused loss to Alliant Credit Union (including, but not limited to the account being closed for cause without repayment of negative balances).

- **TO ENTER BY MAIL WITHOUT BECOMING A MEMBER OR MAKING A QUALIFYING DEPOSIT:** Hand-print your complete name, street address, city, state, ZIP code, and daytime and evening telephone numbers (including area code), and a valid email address on a plain piece of 3" x 5" paper, and mail it in a business-size (#10) envelope with sufficient postage affixed, to: Alliant Credit Union Beyond Boost Sweepstakes, P.O. Box 7773, Melville, NY 11775-7773 ("**Mailed Entry**"). Mailed Entries must be postmarked by the Entry Period End Date and received by the "Received By" end date listed in the chart above in order to be included in the random drawing for the respective Entry Period. Each Mailed Entry will count as one (1) entry into the respective random drawing and must be mailed in a separate, postmarked-and-stamped envelope. Limit one (1) Mailed Entry per Entry Period for a total of up to four (4) Mailed Entries overall for the Sweepstakes Period. Mailed Entries that are mechanically reproduced, copied, illegible, incomplete, postage due, late or inaccurate and Mailed Entries by any means which subvert the entry process are void. Mailed Entries become the property of the Sponsor and will not be acknowledged or returned. Incomplete Mailed Entries or Mailed Entries not complying with these Official Rules are subject to disqualification, at the Sponsor's sole discretion. Proof of mailing does not constitute proof of delivery.

Automatic Entries and Mailed Entries will be collectively referred to as ("**Entries**") or individually as an ("**Entry**"). **Limit up to four (4) Entries [one (1) per Entry Period] per person for the Sweepstakes Period, regardless of method of Entry.**

5. **DETERMINATION OF WINNERS/WINNER NOTIFICATION:** There will be one (1) random drawing conducted from among all eligible Entries received during the Sweepstakes Period to randomly select twenty-five (25) potential Grand Prize winners. The random drawing will be conducted on or about January 12, 2027, under the direction of Administrator, an independent judging organization. Administrator's and Sponsor's decisions are final and binding on matters relating to this Sweepstakes. Potential winners will be notified by email and/or telephone within five (5) business days of the random drawing date. Potential winners will be required to verify their eligibility by digitally completing and securely signing and returning a Declaration of Compliance, Liability Waiver and Publicity Release where legal (the "**Declaration**"), within forty-eight (48) hours of notification. Non-compliance within this time frame and/or with these Official Rules, Sponsor's inability to contact a potential winner within a reasonable time period, or prize or prize notification returned as undeliverable will result in such potential winner's disqualification and, at Sponsor's discretion, such prize may be awarded to a potential alternate winner.
6. **ODDS:** The odds of winning a prize are dependent upon the total number of eligible Entries received during the Sweepstakes Period.
7. **PRIZES AND THEIR ACTUAL RETAIL VALUE ("ARV"):** **Twenty-five (25) Grand Prizes:** Each prize consists of \$1,000, awarded in the form of a cash deposit or check as described herein. Automatic Entry winners or Mailed Entry winners who are currently Alliant Credit Union members, will receive the prize as a deposit to the winner's eligible Alliant Credit Union High-Rate Savings (S01) account (account must be in good standing and not have a negative balance at time of prize award). Mailed Entry winners who are not currently Alliant Credit Union members and do not wish to become a member and open an eligible Alliant Credit Union High-Rate Savings (S01) account, will receive the prize as a check payable to the winner. In any other event where a winner cannot receive the prize as a deposit to the winner's eligible Alliant Credit Union High-Rate Savings (S01) account, they will receive the prize as a check payable to the winner. No substitution or transfer of prize permitted except at the sole discretion of the Sponsor, who reserves the right to substitute a prize (or portion thereof) with one of equal or greater value, except as otherwise provided herein. **There is a limit of one (1) prize per person or household during the**

Sweepstakes Period.

- 8. CONDITIONS OF PARTICIPATION:** By entering, Entrants agree to be bound by these Official Rules, including all eligibility requirements and the decisions of the Sponsor and Administrator, which are final and binding. By accepting a prize, each winner consents to the use of his/her/their name, image, likeness, photograph, voice, and biographical material for advertising, publicity, and promotional purposes by Sponsor, in any and all media now or hereafter devised, including but not limited to, any online announcements, worldwide in perpetuity, without additional compensation, notification, or permission, except where prohibited by law. Entrants release and hold harmless Releasees from any claims, actions, injury, loss, or damage of any kind, including but not limited to, personal injury or death, resulting, directly or indirectly, in whole or in part, from participating in this Sweepstakes or from the acceptance, possession, or use or misuse of prizes. This limitation of liability is a comprehensive limitation of liability that applies to all damages of any kind, including (without limitation) compensatory, direct, indirect, or consequential damages; loss of data, income or profit; loss or damage to property; and claims of third parties. Entrants agree that Releasees have not made nor are in any manner responsible or liable for any warranty, representation, or guarantee, statutory, express or implied (including but not limited to, the implied warranties of merchantability, title, and fitness for a particular purpose), in fact or in law, relative to the Sweepstakes.
- 9. GENERAL:** Sponsor and Administrator will collect information from the Entrants for the purpose of the prize drawings and to notify winners, except in the case of Automatic Entries in which case Sponsor will also use (and continue to use) Entrants information to provide products and services to Entrant in accordance with Sponsor's privacy policy. By entering the Sweepstakes, Entrants hereby agree to all personal information uses and disclaimers as explained in Sponsor's privacy policy located at <https://www.alliantcreditunion.org/privacy>. Sponsor will not share this information with any third party (except as necessary for the administration of the Sweepstakes, or to provide products and services to Entrant if Entrant is a member of Sponsor), nor attempt to contact an Entrant, unless Entrant is already a member of Sponsor, or has otherwise agreed to receive further information on Sponsor's products and promotions. Entrant may opt-out of receiving future communications as set forth in Sponsor's privacy policy or as provided within any such communications (e.g., using the "Unsubscribe" feature provided in the footer of Sponsor's emails). Releasees are not responsible for lost, late, illegible, misdirected, inaccurate, incomplete, undelivered, damaged, delayed, garbled, postage-due, or stolen Entries that are lost, misdirected, or fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly; or for any other errors or problems of any kind, whether typographical, printing, mechanical, human, electronic, or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, any error or problem that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes, or any prize-related event, or in any Sweepstakes-related materials. Entry materials that have been tampered with or altered are void. Sponsor reserves the right, in its sole discretion, to cancel or suspend part or all of this Sweepstakes at any time without notice and for any reason including, if in the Administrator's opinion there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes; or if virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness, or integrity and proper play of the Sweepstakes; a public health crisis; or if any government regulations, orders, or guidelines affect the Sweepstakes. In the event of cancellation, Sponsor may void any entries it suspects are at issue and, at its discretion, if terminated, award prizes in a random drawing from among all non-suspect, eligible entries received up to the date of cancellation. **Caution: Any attempt by an Entrant or any other individual to damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and, should such an attempt be made, the Sponsor reserves the right to seek any and all remedies available from any such person to the fullest extent permitted by law.** Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. Sponsor reserves the right to disqualify Entrants who violate these Official Rules or interfere with this Sweepstakes in any manner.
- 10. TAXES:** The value of each prize will be taxable to applicable winner as income. All federal, state and local taxes and any other costs and expenses associated with the acceptance and/or use of a prize not specifically provided for in these Official Rules are solely the responsibility of the applicable winners.

Winners are solely responsible for reporting and paying any and all applicable taxes.

- 11. DISPUTES:** Except where prohibited, all issues/questions concerning the construction, validity, interpretation, and enforceability of these Official Rules and the Declaration or the rights and obligations of the Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Illinois. Jurisdiction and venue shall be solely within the State of Illinois.
- 12. FORCE MAJEURE:** In the event an insufficient number of eligible entries are received to award the prizes and/or Sponsor is prevented from awarding the prizes or continuing with this Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, regulation, or guideline, public health crisis or pandemic (e.g., Coronavirus), order of any court or jurisdiction, or other cause not reasonably within Sponsor's control, regardless of whether any such cause was foreseeable (each a "**Force Majeure**" event or occurrence), then Sponsor shall have the right to modify, suspend, or terminate this Sweepstakes. If this Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the potential winners in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such random drawings shall be each Entrant's sole and exclusive remedy under such circumstances.
- 13. ARBITRATION:** Except where prohibited by law, as a condition of participating in this Sweepstakes, Entrant agrees that (i) any and all disputes and causes of action arising out of or connected with this Sweepstakes or prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the Entrant; (ii) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (iii) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and Entrant further waives all rights to have damages multiplied or increased.
